#### 1. Subject and Aim of the Study Program

The subject of distance learning is the acquisition of knowledge in the selected subject area. The aim of the course is to give participants the knowledge and skills they need to apply this knowledge in practice.

#### 2. Requirements

There are no requirements for admission to a distance learning course at the Vedic Academy.

### 3. Beginning of Studies

The course begins on the day on which the student receives the first study material.

# 4. Study Material

Together with the registration confirmation, the student receives their study material from the Vedic Academy for the distance learning course they have taken. The study material becomes the property of the student.

#### 5. Correction and Task Solution

Tasks must be completed for each session. The answers for each lesson are to be sent to the study supervisor. The study supervisor corrects and evaluates the student's answers and, if necessary, explains their corrections. The supervisor is available for the student throughout the distance learning course and is ready to answer any technical questions.

#### 6. Graduation

The Vedic Academy honours each separately marked section of the course with its own certificate. In the study description the designations of the respective certificates are specified in detail. If the task solutions and the project work were evaluated at least with the note sufficiently, the student receives the authorization to participate in the conclusion examination. After successfully passing this examination with at least the grade of "sufficient", the student receives the corresponding certificate from the Vedic Academy. The final examination takes place in writing from home. Note: The distance learning courses of the Vedic Academy are state-registered. This makes it possible to issue the certificate documents with the title of Diploma. The award of the nationally protected name title "Diploma", is however reserved for the national universities and professional schools.

#### 7. Duration of Study

In principle, the student can arrange their studies individually within the framework of the duration of study period specified in the application for the distance learning course. After the end of the standard study period for one contract period, there is the possibility of free supervision for a further three months. The contract is automatically extended free of charge for this period of time if you take advantage of the three months. If the student want more additional supervision, an additional supervision fee of 80 EUR per month will be charged.

# 8. Tuition Fees

According to the Distance Learning Protection Act, tuition fees will not increase during the term of the contract. The tuition fees include all teaching materials, supervision by qualified tutors during your studies, correction of homework and project work. Tuition fees must be paid in the specified instalments on the 15th of each month. The first instalment is due on the 15th of the month following the signing of the contract.

# 9. Termination of the Study Contract

The participant may terminate the distance learning contract without giving reasons up to the end of the first six months after signing the contract by giving six weeks' notice and at any time after the end of the first six months by giving three months' notice to the end of the

month. The right of the organiser and the participant to terminate the contract for good reasons remains unaffected. The cancellation must be made in writing. This contract has a minimum term of 6 months.

### 10. Social Guarantee

If unforeseeable reasons arise after the student has started studying (prolonged illness, unemployment), the student can apply for deferment of payment of the next due fees. The application must be made in good time before the due date.

The request will always be granted if the student has duly made the payments due by that date. If the Vedic Academy grants him deferrals of his payments, he is nevertheless entitled to continue his studies unhindered.

# 11. Default / extraordinary termination / compensation

If the participant is in arrears with at least 3 monthly instalments and there is no deferment according to § 10, Vedic Academy is entitled to terminate the study contract without notice.


In the case of a justified termination according to § 11, the participant owes a flat rate of 70% of the agreed tuition fees, regardless of how much of the course the participant has already completed. The participant is permitted to prove that no or less damage has been incurred. The Vedic Academy is entitled to prove higher damages.

# 12. Contractual Security

For the student and the Vedic Academy, the rules set out in this registration form apply. Together with the confirmation of registration and a copy of the contract document, the student will receive a detailed description of the studies he/she has completed.

# 13. Place of Jurisdiction

The place of jurisdiction is the student's place of residence.



#### **Right of Cancelation**

You have the right to revoke this contract without giving reasons.

The revocation period is 14 days from the day the contract is signed.

To exercise your right of withdrawal, you must inform us (Veden-Akademie, Darritzer Str. 6, 16818 Kränzlin, Email: info@veden-akademie.de, Telefax: 03391-4002299, Telephone: 03391-4002218) of your decision to withdraw from this contract by means of a clear declaration (e.g. a letter, telefax or e-mail). You can use the attached sample revocation form, which is not mandatory.

In order to comply with the cancelation period, it is sufficient for you to send the notification of the exercise of the right of cancellation before the expiry of the cancelation period.


#### **Consequences of Cancellation**

If you revoke this Agreement, we shall reimburse you immediately and no later than fourteen days from the date on which we received notice of your revocation of this Agreement for all payments we have received from you, including delivery charges (other than additional charges arising from your choice of a method of delivery other than the cheapest standard delivery offered by us). We will use the same means of payment used by you in the original transaction for such refund, unless expressly agreed otherwise with you and in no event will you be charged for such refund.

We reserve the right to refuse reimbursement until we have received back any study material sent to you or you have provided proof that you have returned the study material, whichever is earlier. You must return or hand over the study material to us immediately and in any case no later than fourteen days after the day on which you notify us of the cancellation of this contract. The deadline is met if you send the study material before the expiry of the fourteen-day deadline (postmark).

You shall bear the direct costs of returning the study material. You only have to pay for any loss in value of the study material if this loss in value is due to a handling by you that is not necessary for testing the quality, properties and functionality of the study material.

If you have requested that the services be commenced during the cancellation period, you shall pay us a reasonable amount equal to the proportion of the services already provided by the time you notify us of your exercise of the right of cancellation in respect to this Agreement relative to the total amount of services provided under the Agreement.
